He informed the house that this emergent meeting had been called to discuss and deliberate on the Inquiry Committee's report received on 05 Feb 2022 related to the issue of Indian athletes impersonating as Nepalese citizens and their participation on behalf of Nepal in the ITPF World Cup Tent Pegging Qualifier held at Gautam Buddha University, Greater Noida wef 15 to 18 Mar 2021. The Inquiry Committee established on 31 Mar 2021 as per the decision of EC of EFI. The nominated chair requested the Secy Gen to proceed with the agenda.
