**MINUTES OF 49th ANNUAL GENERAL BODY MEETING OF EQUESTRIAN
FEDERATION OF INDIA HELD ON 31st JUL 2010 AT DEFENCE SERVICES
OFFICERS' INSTITUTE, DHAULA KUAN, NEW DELHI**

1. The 49th Annual General Body Meeting of Equestrian Federation of India was held on 31st Jul 2010 at Defence Services Officers Institute, Dhaula Kuan, New Delhi under the Chairmanship of Lt Gen SS Kumar, PVSM, AVSM, SM, VSM, the President EFI.

2. **President's Address :-**

2.1 Lt Gen S S Kumar, PVSM, AVSM, SM, VSM welcomed the members attending the AGM. He underlined the salient points about selection process of teams for ASIAD. He mentioned about efforts made to ensure transparency of selection process. He recounted about the process whereby EFI has integrated itself in the development plan of the Federation Equestre Internationale. He briefed the members about his meeting with the Minister for Youth Affairs & Sports, Mr M S Gill, and the important issues discussed with him.

2.2 Speaking about the Quarantine & Veterinary Protocol hurdles in the way of movement of the horses for forthcoming Asian Games, the President assured the members that all out efforts are being made to accomplish the task of moving horses to China. Touching upon the EFI development plan to broad base the equestrian sport, the President informed the members that Pune, Dibrugarh and Bangalore/Chennai have been tentatively identified for development as training Centres. He expressed his entire satisfaction about the conduct of events during the current season and especially mentioned the international events conducted at Dibrugarh (Endurance) & Noida (Tent Pegging). He assured the members that every suggestion from them is given due consideration and the EFI is open to new ideas in the interest of the sport. In the end, he thanked the members for contributing to the functioning of the EFI.

3. **AGENDA NO :1 The minutes of last AGM.** The Secretary General briefed the house about the actions taken on last AGM points.

- (a) **New Logo** . The new logo has been Implemented wef 01 April 2010.
- (b) **Statutes**. Amended Statutes have been printed in English and Hindi and placed on Federation website (English version).
- (c) **Committee to review EFI membership.** A committee consisting of following members was formed to review the membership especially of Clubs and Defence units. The committee is of the view that these are directly or indirectly involved in equestrian activities & the status quo should be maintained. The members of the Committee were :-

(d) **Coffee Table Book**. Ms Gillian Newsum of England has been asked to do text for a book on equestrian activities in India. The book is likely to be completed by September 2010.

4. The minutes of last AGM were proposed to be passed by Lt Col V K Bhatnagar (retd) and seconded by Col Tarsem Singh.

5. **AGENDA NO 2: Secretary General's Report.** The Secretary General underlined the major issues of the preceding year as at succeeding paragraphs.

FEI AGM

(a) FEI AGM at Copenhagen was attended by the President and the Secretary General in November 2009. Interaction with a number of discipline members of the FEI was quite productive. During a meeting with Member Dressage, our trials, Jury and selection of team was discussed, and on his recommendations, jury members were invited. The President informed the house that the Judges for ASIAD Trials were recommended by these experts from FEI and it has helped in ensuring transparency.

(b) The FEI has integrated India in its development programme. Mr Andrew Griffith, Deputy Chairman, Eventing Committee (FEI), visited India and a development plan was formulated for development of Eventing in India. The Development Plan was flashed & discussed for the benefit of the members.

(c) The next AGM is at Taipei from 01st November to 06th November 2010 and President & Secretary General will be attending the same.

7. **ASIAN GAMES TRIALS**

(a) The conduct & results of Trials for Eventing & Dressage schedule as at **Appendix 'A'** were discussed by the Secretary General.

(b) **SHOW JUMPING**. After conducting the five trials, no rider from India has qualified to participate in the Asian Games.

(c) Ms M Sahlot, mother of a rider Master Angad Sahlot, thanked the house for encouragement given to her son for competing at the Trials. She requested the house that her son be given another chance to qualify. The President intervened to assure that her request will be examined at an appropriate level & she will be informed about the decision shortly.

(d) **Sponsorship** The Secretary General thanked the sponsors (Embassy International Riding School, Health India Medical Services Pvt Ltd & DAAKS International) for the assistance in transportation of International jury for eventing & dressage.

8. **Changes in Selection Criteria**. The Secretary General informed the house about the amendments made by the Selection Committee in the Asian Games Selection Criteria, which were ratified by the EC. The amendments are at **Appendix 'B'**.

9. **Dope Testing during Trials**. The Secretary General informed the house that the dope testing has been carried out for the Eventing and Dressage Trials.

10. **Technical Guidelines**. The Secretary General informed the house that the New Technical Guidelines are available on Federation website after being deliberated upon in the EC.

11. **Competition abroad :-**

- (a) Ms Aliya Das Gupta represented our zone in FEI World Jumping Challenge Final at Santiago (Chile) from 02nd November to 08th November 2009.
- (b) **World Equestrian Games : Kentucky**. An Indian rider based in USA, Mr Mustafa H Tehrani, will represent India in Endurance Discipline during World Equestrian Games in September 2010.

13. **Govt Guidelines** – The Secretary General briefed the house about the new guidelines issued by the government.

- (a) **Right To Information Act**. As per Ministry of Youth Affairs & Sports letter dated 30th March 2010, all National Sports Federation have come under the RTI Act.
- (b) **Cap on Tenures and Indian Olympic Association**. As per latest policy, the President of NF/IOA can hold the post for a maximum period of 12 years with or without break and the Secretary General/Treasure may serve a maximum of two successive terms of four years.

14. **VETERINARY PROTOCOL : BRIEFING BY VICE PRESIDENT (VET)** The VP (Vet) briefed the house about Quarantine and Veterinary protocols for Asian Games. Maj Gen R M Kharb (Retd) stressed that the EFI should adopt the Chinese model to implement the quarantine and segregation measures. Col Sarpratap Singh (Retd) suggested that EFI should take up a case to become a scheduled country. The President expressed his concern about the discriminatory regulations of the International Community in regard to export/import of horses.

15. **Progress on Court Cases**. The Secretary General discussed the Court Cases of the EFI as at **Appendix 'C'**.

16. **Membership :-** The Secretary General informed the house that the Federation membership is on the increase which is an encouraging sign as it reflects growing interest in the sport :-

18. **Rider's Licence** :- The Federation has introduced a Rider's Licence for technical and administrative monitoring of all equine athletes.

19. **Horse Passports** :- The Federation has introduced horse passports for monitoring all sport horses.

20. **MOU With Equisport.** The MOU was not formalized as Equisport desired to withdraw their proposal.

21. **Railway Concession for horses.** The Federation has approached the concerned authorities and the action is in hand for the same.

22. **Suggestions** :- The Federation, from time to time, requests its members for suggestions. The response to this is, however far from encouraging. Members were requested to be more forthcoming in airing their viewpoints & sending there to EFI.

AGENDA NO :3 PASSING OF ACCOUNTS

23. **Accounts :-** The accounts were passed after being proposed and seconded by Major JS Ahluwalia (Retd) and Col SS Solanki respectively.

24. **AGENDA NO :4 APPROVAL OF PROPOSED BUDGET.** The proposed budget was discussed & was passed after being proposed & seconded by Col S K Dagar (Retd) & Mrs Roshan Sodhi.

25. **AGENDA NO : 5 Calendar of Events.** During the discussion on the Calendar of Events, Sh RS Dundlod pointed out that a few of the events which were not discussed during the EC are part of the Calendar. Sh BVP Rao opined that a JNEC event should be held in South. Col S S Solanki (Retd) suggested that the Calendar need be passed pending the discussion about these events in the EC. The Calendar was passed after being proposed & seconded by Ms Roshan Sodhi and Col SS Solanki (Retd).

26. **AGENDA NO :6 NEW MEMBERSHIP** : The Secretary General informed the house about the new membership accorded during last year (**Appendix 'D'**).

AGENDA NO :7:POINTS FROM MEMBERS

27.1 (a) COL SUBODH GARG :AMENDMENT TO ART.05.3 AND 4:1:3:

Authority to grant membership should rest with EFI and not State Associations.(Para 15.1 minutes of ECM 08th Jan 2010).

(b) COL UMAID SINGH RATHORE(RETD): AMENDMENT TO ARTICLE 030:ELIGIBILITY AND CRITERIA FOR THE ELECTION OF REGIONAL MEMBERS.

27.2 The above proposed amendments were debated with inputs from Sh RS Dundlod, Mr Gaurav Joshi and Mrs Sunaina Mishra. The President concluded the debate by opining that it will be discussed again at appropriate forums. Sh BVP Rao suggested that a Committee comprising of members from Police, Civilian & Army should discuss it at length. The house agreed to the proposal.

27.3 **HORSES FOR INTERNATIONAL COMPETITIONS HELD IN INDIA:**
ECM MINUTES :39.2: 29 MAR 2010:"After prolonged discussion on the subject of giving horses for international competition, it was decided that Statutes should be duly amended to incorporate the required provisions.

ADD:- DURING A COMPETITION FOR THE EVENT/SELECTION TRIALS, PRECEDING AN INTERNATIONAL EVENT ,ANY HORSE DURING THE EVENT SELECTED FOR INDIAN/FOREIGN TEAM WILL BE PROVIDED BY THE RIDER/UNIT/CLUB WITHOUT ANY PRECONDITIONS, FAILING WHICH RIDER/UNIT/CLUB CAN BE DEBARRED FROM PARTICIPATION FOR UP TO THREE YEARS”.

The above was passed by house after being proposed & seconded by Col Tarsem Singh & Col S S Solanki (Retd) respectively.

28. **Vote of Thanks** :- In the end, a vote of thanks for the outgoing EC members was proposed and seconded by Lt Gen GS Dhillon and Maj Gen RKR Balasubramanian (Retd).

29. There being no other points, the proceedings of elections for EC members commenced and the Election Commissioner announced the list of elected members as at **Appendix 'E'**.

- (a) **Para 14.** Indian riders based abroad will have to give details of all the competitions they desire to participate in and reckoned as a selection competition by 30 days before the competition and the last date of trials have been extended till 30th June 2010. Sh BVP Rao opined that the Federation must encourage riders from India to get training and compete abroad.
- (b) **Para 33.** Total 08 riders will be selected for Eventing.
- (c) **Para 38.** After the trials, the National Federation is empowered to explore the possibilities of leasing/purchasing better quality of horses. The Selection Committee along with inputs from the coaches will decide the final selection of the team and horse/rider combination.
- (d) **Para 41** "The height for all the selection competitions for Indian Team will be 140cm(max) and spread 160cm(max). 66% of the Jumping course will be of full height and full spread. Indian team entry will be forwarded of 04 riders , score a maximum upto 08 penalties over two rounds per trial. 05 trials will be conducted; best performance in 03 out of the 05 trials for team selection will be taken into account. In exceptional circumstances, if sufficient number of competitors/competitions are not available in India, the EFI may allow riders based in India to compete abroad in recognized competitions and forward results for consideration of selection for the Team.
