

**MINUTES OF 52nd ANNUAL GENERAL BODY MEETING OF EQUESTRIAN
FEDERATION OF INDIA HELD ON 21st JULY 2013
AT DEFENCE SERVICES OFFICERS' INSTITUTE,
DHAULA KUAN, NEW DELHI**

1. The 52nd Annual General Body Meeting of Equestrian Federation of India was held on 21st July 2013 at Defence Services Officers' Institute, Dhaula Kuan, New Delhi under the Chairmanship of Lt Gen Munish Sibal, PVSM, AVSM** President EFI. The meeting was attended by 261 members.



AT RVC CENTRE & COLLEGE MEERUT

EXPERT COMMITTEE :PEQ 04 APR 2012

1. Expert committee constituted by Min of Agri as under-
 - (a) Dr Praveen Malik, Principal Scientist, NRCE, Hissar

2. Terms of reference for the committee as under-
 - (a) To inspect the PEQ loc at RVC C&C at Meerut Cantt
 - (b) Certify the infrastructure & other reqmt
 - (c) Decide laboratory test reqmt during quarantine
 - (d) Recommend suitable measures for safe transport of horses
3. Expert committee visited the proposed PEQ at RVC C&C, Meerut on 04 Apr 2012 and submitted report on 30 Apr 2012
4. Observations made by committee on PEQ were communicated to RVC C&C by Dte on 22 May 2012.
5. The observation made were predominantly infrastructure related and the same addressed by releasing funds for initial work . Accordingly sum of Rs 70 lacs allotted as dedicated fund to RVC C&C on 10 Sep 2012. The work on PEQ expedited with release of fund and with constant monitoring from this Army HQ. The progress on PEQ going on at good pace.
6. On 17 Jun 2013 meeting was held between ADGRVS, DTE Gen RVS, IHQ OF MOD and Secretary (DADF), Min of Agriculture, GOI at Krishi Bhawan
7. Discussion on the quarantine issue for export of horses for sports purposes to EU was deliberated
8. Copy of the draft Vet Protocol: Quarantine Regulation of import of horses to Korea for 17th Asian games was handed over to ministry of agriculture

9. Team of experts under chairmanship of ADGRVS visited the PEQ at RVC Centre & College, Meerut on 22 Jun 2013. The members of the team were as under -

10. **The committee recommended declaring RVC C & C as equine disease free zone rather than PEQ with stringent requirements in terms of Biosecurity, Surveillance, Testing, Monitoring of diseases as per EU norms.**

11. Subsequent to meeting of ADGRVS and Maj (Retd) J S Ahluwalia with Hon'ble Shri Sharad Pawar, Agriculture Minister, Govt of India on 25 Jun 2013, it was decided to invite EU experts to inspect PEQ facility

12. On 26 Jun 2013 formal invitation letter to Mr Peter Young was extended by DADF, Min of Agriculture to invite the EU team for inspection of the proposed PEQ. reply awaited

13. In meeting between Secretary (DADF), Min of Agriculture, ADGRVS & Maj (Retd) J S Ahluwalia on 25 Jun modalities for EU team vis were discussed & detailed modalities for inspection by EU team have been recd from Maj J S Ahluwalia & are being examined
