<p>6. EFI Calendar 2019-20. The Secretary General informed the house that EFI Calendar for 2019-20 needs to be finalised. The bids received from various quarters was flashed before the house. He also said that adequate time had been given, yet no bids were received except for JNEC 2019 & FEI Jumping Children Classics 2019. He appraised the house that the calendar flashed before the EC has been prepared keeping in view the past precedence and rotation of events so that the ACTC can be prepared and submitted to Sports Authority of India (SAI). The Secretary General suggested that being a single bid received for conduct of FEI Jumping Children Classics 2019, the event be given to MP Equestrian Academy, Bhopal and out of the two bids received for JNEC the EC may consider allotting the JNEC to EIRS Bangalore as they had bid for the same event last year also. He further suggested that the Army establishment must conduct the events which have been allotted to them and in case of any difficulty in taking on the responsibility the same may be communicated to EFI before 25th Apr 2019 as the EFI Calendar needs to be finalised by 30 Apr 2019. <p>7. Regional Equestrian League (REL) Guidelines 2019-20. The Secretary General informed the house that during last meeting, the EC had recommended few changes and those recommendations have been incorporated in the Regional Equestrian League (REL) guidelines for 2019-20. The Guidelines attached as Appendix 'D'. During the discussion, Mr Naresh Tehlan, Comdt pointed out an important issue that people are using same horse for different events in a day (i.e. for two or three rounds of Show Jumping & for two or three rounds of Dressage).</p>	<p>Decision of the EC. The house also recommended that a horse should not be allowed to participate in more than three rounds of events (i.e. two normal jumping rounds and one side event or two dressage competition and a side event of Jumping or two rounds of jumping normal and one dressage competition) in a day, in Children Category and not more than two rounds of events in Junior/Young/ Senior Category in a day. <p>7.1. <u>Conduct of Regional Equestrian League (REL) different Zones.</u> Secretary General informed the house that during last EC a committee consisting of Vice President (Sports Development) & Regional Members was formed and tasked to recommend the number of RELs that should be conducted in each Zone. The recommendation of the Committee was flashed in the house (attached as Appendix 'E'). The Secretary General also said that it will be the responsibility of respective Regional Members to decide the venue of the RELs in their respective zones in liaison with different organisers and their recommendation should be given to the EFI Secretariat in order to incorporate the same in the EFI Calendar for 2019-20. 9.1 <u>Results of events after last EC:-</u> The Secretary General presented the results of all events held wef 20 Jan 2019 to till date. Details of all events and results are attached at Appendix 'H' . Secretary General also apprised about the Coaching Camps conducted during the period. While flashing the details of Eventing Coaching Camp held at Bangalore, Brig Deep Ahlawat, VSM, Member Eventing said that Mr Rodolphe Scherer, Olympian and Indian Eventing Coach for 18 th Asian Games was having some observations regarding the status of riders detailed for such camps as he had come across Novices.	<u>Decision of EC:-</u> The house perused the results of all events. <p>9.4 Annual Calendar for Training & Competition (ACTC) 2019-20. The Secretary General informed the house about the projection of budget through Annual Calendar for Training & Competition (ACTC) 2019-20 to Sports Authority of India (SAI) (attached as Appendix 'J'). At this juncture, Col PP Singh (Retd) brought out the issues of outstanding payment of Mr Rodolphe Scherer, Indian Eventing Team Coach for 18th Asian Games. He also appraised the efforts of the Coach and the same was applauded by the house. The Secretary General informed the house that the claim has already been forwarded to the Government and the fund is yet to be released. Once the amount received from the Govt, we will clear all outstanding payment to all stakeholders.</p>	<p>Decision of the EC. The house perused the ACTC programme and approved the same. The President directed that this being a National Sports Federation representing India at the International level and services of the individual has been utilised, have to remunerate them rather than making it contingent on receipt of Govt funds. The Secretary General said that first, we have to decide an organizer for the event and then only we have to bid for the event. <p>9.6 Trophy for National Champions. The Secretary General informed the house regarding a suggestion received from Mr MS Rathore that every national champion should be awarded with a National Champions Trophy. He also appraised the house that Mr Naresh Tehlan, Comdt is willing to donate a trophy for Eventing discipline in the name of his father (Col OP Tehlan (Retd)) and the same was applauded by the house. Col Rajesh Pattu, SJRP, VSM (Retd) said that the NF is already having a National Champions Rolling Trophy for Eventing and that should be continued. The Secretary General informed that house that after having checked, all those trophies which are held for National Champions, the same will be continued. Mr Naresh Tehlan, Comdt then agreed to donate the trophy for some other discipline.</p>	<p>Decision of the EC. The Secretary General informed the house that during the last EC meeting held on 19 Jan 2019, a committee has been formed, consisting of Brig GS Puri, Vice President (Tech), Col PP Singh (Retd), Member Eastern Region & Col Tarsem Singh, Member Tent Pegging to recommend remuneration for Indian FEI Officials (retired military officers and civil officials) detailed for the events in India. The recommendation of the committee is attached at Appendix 'K'. Lt Gen MH Thakur, AVSM, VSM, Vice President (Adm) pointed out that a detailed analysis be carried out on the types of Organising Committee, types of venue employing such officials and their capability to pay the same.  - (h) Assam Rifles.



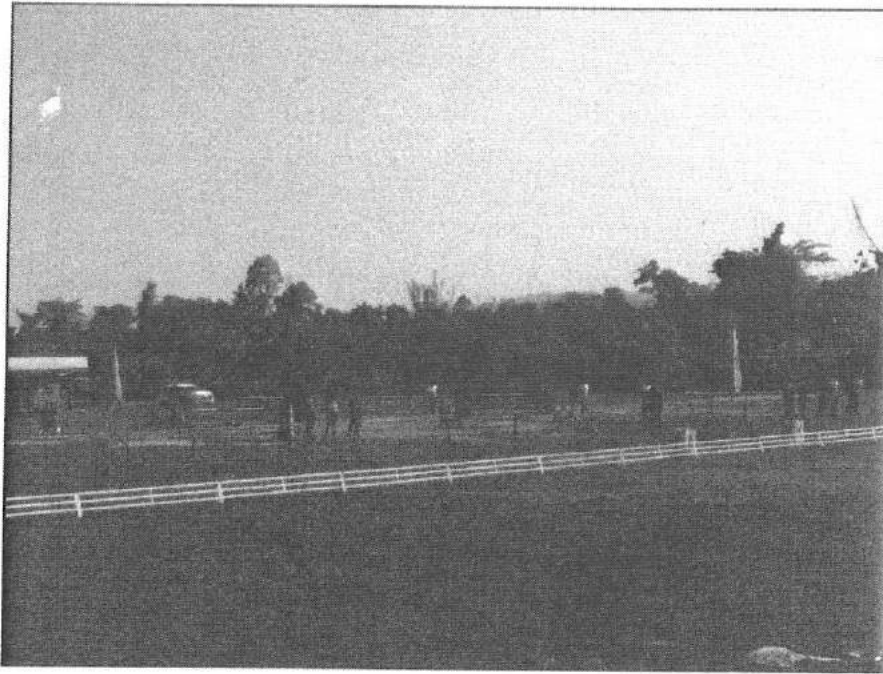


TENT PEGGING AREA

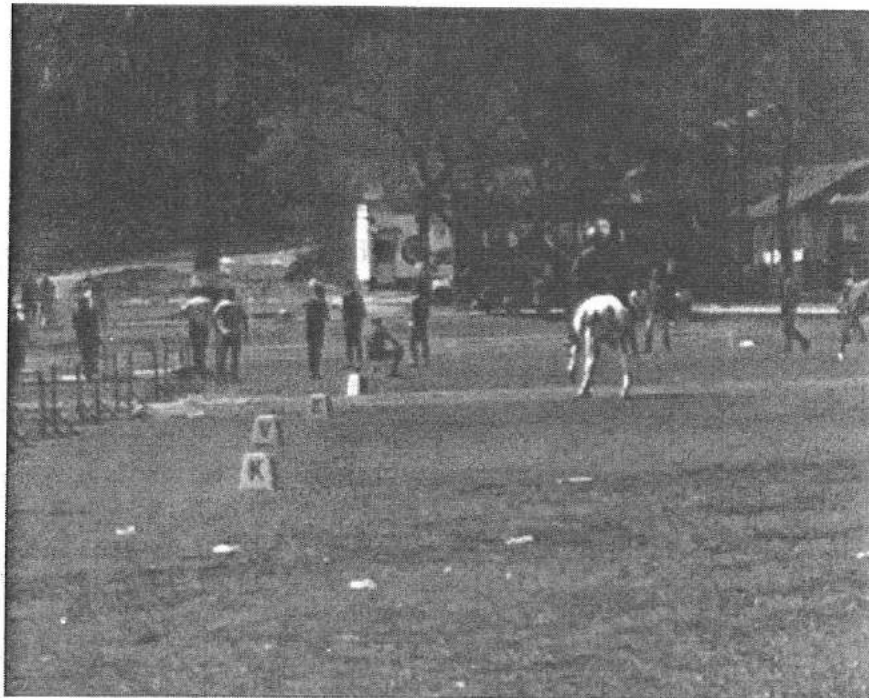

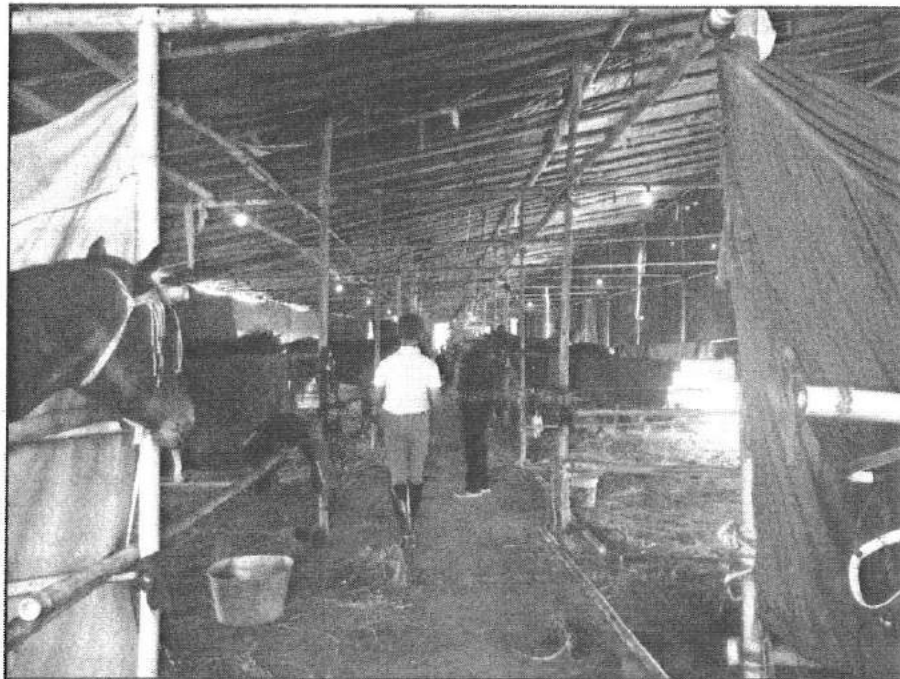

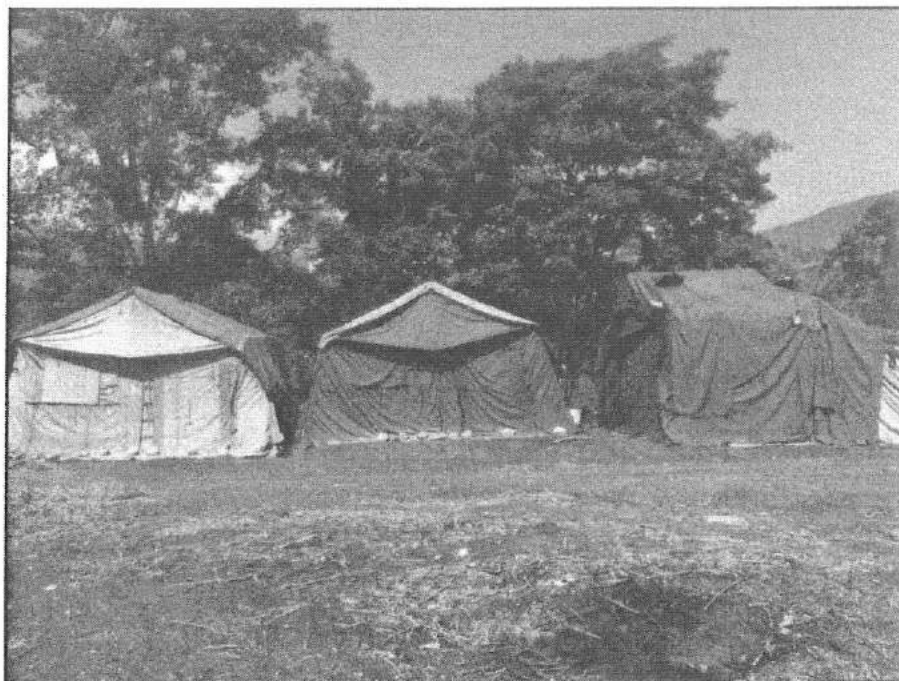

GUIDELINES : SHOW JUMPING, TENT PEGGING & JNEC

INTRODUCTION

1. Unlike other sports, equestrian field does not have Distt / State level championship due to lack of infrastructure, as a result of which many a time naïve horse-rider combinations have participated in National championships thereby diluting the sanctity of the National Level competition. REL concept has been developed to offer more opportunities to riders to participate in various competition within the region and qualify themselves to compete at National level.

OBJECTIVE

2. (a) Promote Equestrian sports at Regional Level by empowering Regional Members.
- (b) Promote more civilian organizing committee & civil venues to hold equestrian events.
- (c) Popularize the sports throughout the country.
- (d) Offer more competitions to horse-rider combinations in their own region thereby reducing the burden of transportation cost.
- (e) Select horse rider combination worthy of participation at National level.

CONCEPT

3. To achieve the above objectives, holding of Equestrian competitions at regional level is proposed on the lines of World Challenge Jumping (WCJ) for which the country will be divided into following zones: -

- (a) North Zone (J&K, Himachal Pradesh, Punjab, Haryana and Union Territories of Chandigarh and Delhi).
 - (b) East Zone (West Bengal, Bihar, Jharkhand and Orissa).
 - (c) West Zone (Maharashtra, Goa, Gujarat, and Rajasthan).
 - (d) South Zone (Tamil Nadu, Kerala, Karnataka, Andhra Pradesh, Telengana and Puducherry).
 - (e) Central Zone (UP, Madhya Pradesh, Chhattisgarh and Uttrakhand).
 - (f) North East Zone (Assam, Manipur, Nagaland, Sikkim, Arunachal Pradesh, Tripura, Meghalaya and Mizoram).
4. Respective Zonal Members shall be responsible to organize regional championships.
5. One EFI Rep (CD/Jury as per the request of OC) shall be detailed for each horse show to ensure that the desired levels are not diluted.

6. Course plans for show jumping will be provided by EFI to be followed at all venues so as to have uniformity in level of competition for all and for Dressage and Tent Pegging uniform standards as per tech guidelines of EFI will be followed. OCs will be at liberty to select one of the course plan out of the course plans provided by EFI.
7. The MER as per **Appendix A** will be followed and rider must achieve 02 MERs at two different venues to be eligible to participate in NEC/ JNEC.
8. To qualify for the Nationals, rider may participate in any number of competitions being held at various venues all over the country to achieve the desired MER.
9. At present REL is introduced only for the following categories:
 - (a) **Seniors**: Only in Show Jumping (Novice & Grade III) and Tent Pegging.
 - (b) **Juniors**: Only in Show Jumping and Dressage (Junior, Children I & Children II).
10. Rest of the categories except mentioned above will not be included in REL and the riders can participate directly in NEC/JNEC as applicable.
11. Expenditure on transportation, accommodation & hospitalities of officials shall be borne by the organizers.
12. Organizers to use their own infrastructure.
13. Course Plans and Dressage tests for these categories are attached as **Appendix 'B' to 'F'**.
14. REL for JNEC will start from the 1st of January every year and for Seniors immediately after the NEC Show Jumping of previous EFI Calendar.

INCENTIVE

15. Incentive will be given by EFI to a club once in a calendar year. Rs 50,000/- will be given if participation of over 25 riders and Rs 25,000/- to be given for less than 25 riders.

PROCEDURE

16. Interested organizers may forward their bids to EFI after due consultation with Regional Member regarding the exact dates of event. The recommendation of Member Region is mandatory. On receipt of the bids the same will be evaluated by the Bid Evaluation Committee for allotment of events. On allotment of the event the same will be included in the EFI Calendar for 2018-19 which will facilitate all horse-rider combinations to plan their move to various venues and participate to achieve MER to qualify for NEC.
17. Organizers will have to deposit a refundable security of Rs 50,000/- alongwith bid which will be refunded with incentive mentioned in Para 15 on successful completion of event. In case of non completion of event as per EFI guidelines security deposit will not be returned.
