Sir.

The undersigned is directed to refer to your letter No.035/EFI/2015, dated 18 Sep 2015 on the above mentioned subject.

The statute of EFI was examined & found that Para 7 Article 13, which deals with the organization and functions of Executive Committee, is not in accordance with the National Sports Development Code, 2011 and needs amendment. The interpretation of the age & tenure guidelines as per your letter is incorrect and also that the clause 7 of Article 13 relating to the age & tenure needs to be revisited.

It is also requested to you to amend your Constitution accordingly to either keep the duration of the tenure of their office bearers as four years or two years, but the number of terms allowed to an office bearer, other than a government employee, remains as specified in the Govt. guidelines. For the Govt. employees, the order of DOPT is applicable, according to which any govt. servant cannot hold elective office in any sports Federation/Association for a term of more than 4 years or for one term, whichever is less.

You are therefore, requested to amend your Constitution and submit a copy of the amended Constitution duly received by Registrar of the Society, immediately.

Sir,

I am directed to inform that election of office bearers of Equestrian Federation of India (EFI) was held on 21.07.2013 & 27.09.2015. The result of the election of EFI was not accepted by Ministry of Youth Affairs and Sports in view of non-compliance of the following provisions of National Sports Development Code of India (NSDCI), 2011:

1. There should be no proxy voting in the election/AGM.

- 2. Government employees should hold office for one term only as per NSDCI, 2011.
- 3. For the Treasurer and Secretary General, there should be cooling off period after two terms as per NSDCI, 2011
- 4. As per EFI's constitution that office bearers can be elected & hold post for $3^{rd} \& 4^{th}$ term if they secure $2/3^{rd}$ majority is a violation of NSDCI, 2011.

In view of the above mentioned deviations from NSDCI, 2011, the annual recognition to EFI for the year 2017 has been withheld. EFI is advised to amend their constitution sutaibly to become fully compliant with NSDCI, 2011. Such amendments may be carried out as early as possible but within 3 months, failing which action would be initiated for de-recognition of the federation. Further Registrar of Societies will also be requested to withdraw permission for the use of the word "India" from the name of your Federation.

THE SELECTION COMMITTEE CONSISTING OF FIVE MEMBERS WILL BE ELECTED **GENERAL ASSEMBLY** BY THE ONLY (NOMINATED) COMMI MEMBERS WHO HAVE WON MEDALS IN ANY OF THE EQUESTRIAN DISCIPLINES THE NATIONAL EQUESTRIAN CHAMPIONSHIPS ARE ELIGIBLE. THEIR TENURE WILL **BE OF TWO YEARS DURATION. THEY CAN SEEK RE-ELECTION (BE NOMINATED) FOR** ANOTHER TERM OF TWO YEARS BY SIMPLE MAJORITY (EXECUTIVE COM THE PRESIDENT SHALL NOMINATE THE CHAIRMAN OF THE SELECTION COMMITTEE TO CONDUCT THE PROCEEDINGS OF THE MEETING. BALLOT PAPERS

Any organisation of an all India standing and connected with the Sport may be given the status as that of a State or that of a U.T.and admitted as affiliated Member. Other categories of membership may also be given. but while each affiliated State/UT Unit shall have a right to cast vote in the General Body Meetings, no other class of Member(s) shall have any right to vote, in the Federation's meetings. While granting recognition/affiliation to a State /UT Association, the National Federation should take into consideration the representative character of the State/UT Association so as to ensure that only truly representative body of the game gets the recognition/affiliation.
