# MINUTES OF 56<sup>TH</sup> ANNUAL GENERAL BODY MEETING OF EQUESTRIAN FEDERATION OF INDIA HELD ON 27<sup>TH</sup> AUG 2017 AT DEFENCE SERVICES OFFICERS' INSTITUTE, DHAULA KUAN, NEW DELHI

1. The 56<sup>th</sup> Annual General Body Meeting of Equestrian Federation of India was held on 27<sup>th</sup> Aug 2017 at Defence Services Officers' Institute, Dhaula Kuan, New Delhi under the Chairmanship of Lt Gen Ashok Ambre, AVSM\*\*, SM, President EFI. The meeting was attended by 170 members.

#### 2. Opening address by the President

- 2.1 The President welcomed all the present members to 56<sup>th</sup> Annual General Body meeting and congratulated all members on completion of fifty years of existence of EFI. He mentioned that the attendance was well above the required quorum. He apprised all the members with regards to the fwg:-
- 2.1.1 The establishment of National Equestrian Academy at RVC Centre and College, Meerut is under consideration. DG RVS is preparing an approach paper for the same.
- 2.1.2 Important steps have been taken by Executive Committee to stop the derecognisation of EFI by the Min of Sports.
- 2.1.3 He expressed the need for amendments to the EFI Statutes to be in sync with NSDCI-2011.
- 2.1.4 The modalities for FEI Solidarity programme have been worked out and programme will start soon.
- 2.1.5 The establishment of Equine Disease Free Zone (EDFZ) is in progress and is likely to be completed by 01 Feb 2018.
- 2.1.6 He expressed the need to increase the no of qualified officials available with the EFI.
- 2.1.7 He expressed the need for State Association to be more proactive and popularize the sport in their area of influence.
- 2.1.8 He requested the members for support in order to improve the standard of the game and laying down of platform for preparation for Asian Games 2018 at Jakarta and Olympic Games 2020 in Tokyo.
- 2.2 He then handed over the proceedings to the Secy Gen.

(b) Recommendations of Committee  After having gone through the fund state available with EFI and pool of qualified officials to judge various events of EFI the committee recommends the following:-		
(i) Organizing Committee of various events be given the liberty to suggest the name of the official whom they want to invite to officiate in various competitions so that they can select officials who will incur least expenditure on them.		
(ii) Organizing Committee should try and detail name of local officials and restrict from detailing out of stationofficials.		
(iii) In case out stations officials are detailed effort should be made to detail in service officials for whom TD can be arranged through QMG's Br if possible so as to reduce burden on EFI Fund.		
(iv) If Organizing Committee decides to invite an outstation official who is not in service, they may do so at their own expense. However, depending on the availability of official if it is inevitable for EFI to detail an outstation official who is not in service and not in a position to meet his expenses the following may be reimbursed by the EFI out of EFI Fund after approval by the EC:-

It is also proposed to exempt NOC fee of riders those who are willing to take selection trials abroad in connection with 18 <sup>th</sup> Asian Games for a period from 01 Jan 2017 to 31 May 2018. 4.11 Corpus Money & Entry Fee. The Secretary General informed the house that the system of corpus money deposit requires to be reconsidered. There should be refundable corpus money for Junior National / National Championships. On successful completion of the event, all entry fees to be deposited to National Federation and thereafter the Corpus Money be released to the respective org. The Secy Gen informed the house that during 55 <sup>th</sup> Annual General Body Meeting, Membership of certain individuals/clubs/units/associations was terminated due to non-payment of Annual Subscription for more than three years at a time. Now, some of them are willing to clear all the outstanding dues and to continue their membership with EFI.As per Para 6 of article 007 of EFI Statute. General Assembly can decide by a two third majority of votes of members present to reinstate a member after hearing his appeal against the termination. Accordingly, the member can be reinstated after paying all the dues and the normal subscription. However the same was added in Statutes of 2008 as additional clause 1.5 of article 004. Statute of 2009 edition and onwards do not have the clause of 1.5 in Article 004. Hence, he proposed that either these members be granted LM with voting rights or be given Honorary/Ex-officio membership without voting rights as per clause 1.4 of Article 004. While discussing the matter Mr Gunesh Purandre of Digvijaya Pratisthan informed the house that MEA is not conducting any activity in the State thereby depriving riders of any opportunity of competitions at State level. In counter to it Mrs Neeta Nihalani the President MEA alleged that Mr Gunesh Purandre has been conducting equestrian events and giving state level participation certificates to riders which is illegal. In reply to this, Mr Gunesh Purandre tendered an unconditional apology to the house and requested MEA to conduct equestrian activities in the State.	After hearing both the parties the President directed that MEA must accept all the clubs in Maharashtra as the members of MEA and they must work together for the development of the sport in the State. Corpus money and entry fees were waived off as decided by the EC. The organisation failed to submit the result to EFI after its completion. As per feedback and results from President Ground Jury no horse rider combination acquired the requisite MER as per the Technical Guideline 2016 for a medal but the org have issued the medals to first three positions. The Secy Gen informed the house that meeting of the Selection Committee was held on 24 <sup>th</sup> Jun 2016 and selection criteria formulated was fwd to all members of EC. It was discussed in the EC on 14 Jul 2016 that the changes suggested were discussed and accepted by the EC. After incorporation of changes it was fwd to selection committee for approval. After approval it was uploaded in NF website. The selection criteria were placed before the AGM for ratification on 24 Jul 2016. There were some representations from the members with regards to number of trials for Eventing discipline. It was decided there will be five trials instead of six trials and results of best three trials will be taken into account. Post ratification certain representations were received. The President exercised his discretionary power and reconvened the meeting of Selection Committee. The Selection Committee finalized the selection criteria on 02 Jan 2017 which was discussed in the EC on 22 Feb 2017 and passed. It was then uploaded on the EFI Website. The Secy Gen further intimated that a minor change in eligibility criteria has been made after obtaining approval of Selection Committee through mail. The change is that the age of the rider should be 16 Years at the beginning of last trial rather than the first trial. While discussing the Selection Committee the following points were raised by various members  10.1 Lt Col (Retd) Sandeep Dewanpointed out that the height of Show Jumping (Team) event is being shown as 1.45 mtr. Secy Gen clarified that the final draft standard has been received from AEF and the height is 1.40 mtr. The same will be rectified. 

#### RECOMMENDED AMMENDMENTS TO REL GUIDELINE

- 1. After detailed discussion regarding amendment in REL Guidelines the house agreed to the following proposals:-
  - (a) Incentive being given by EFI to be given only once to club in a calendar year. Rs 50,000/- to be given if participation of over 12 riders and Rs 25,000/- to be given for less than 12 riders.
  - (b) For Novice and Gde-III third participation not mandatory. Gde-II/I will have direct access to NEC.

### PARTICIPATION OF HORSE/RIDER COMBINATION IN HIGHER GRADE

- 1. As per Para 5 of article 206 of EFI Tech Guidelines, a rider can participate upto two or more grades in a single horse show, if the combination meets the MER as laid down in article 207.
- 2. But as per new concept of Regional Equestrian League (REL), a horse/rider combination have to achieve two MER (less than 12 jumping penalties) in REL for qualifying to take part the NEC in same grade.
- 3. It was proposed that after qualifying for the NEC in a particular grade, if the combination meets the MER of that particular grade during NEC, he may be permitted to take part in the next higher grade.

#### **TEAM ENTRY**

1. In NEC there will be team competition in various grades. However, the clubs may not be able to field teams as the required no of riders may not have qualified through REL. So, it was proposed that although for individual competitions only riders those who have qualified through REL to take part. for the team competitions, anyone with appropriately graded horse be allowed to participate.

#### 2. <u>Decision of EC (03 Nov 2017)</u>

- (a) The house suggested that if the combination meets the MER of a particular grade during NEC, the combination may be permitted to take part in the next higher grade even if the combination has not participated in the REL of the higher grade.
- (b) <u>Team Entry</u>:- For the team competitions, anyone with appropriately graded horse be allowed to participate even if the combination has not acquired qualification through the REL.





#### AMENDMENT IN ELECTIONS BYE LAW

#### **GENERAL**

1. As per Statutes of EFI members of the Executive Committee and Selection Committee of EFI, shall be elected in the General Body Meeting/ Extra Ordinary General Body Meeting. Elections of the members of Executive Committee and Selection Committee will be held once in two years or whenever a vacancy occurs during the General Body Meeting/ Extra Ordinary General Body Meeting. All such elected members will serve a two year term four year term. For Selection Committee members the term will terminate at the AGM/ election succeeding the Asian games.

#### **ELECTION COMMISSION (EC)**

- 2. The Secretary General in consultation with the Vice President (Administration), will detail the Election Commission. The responsibility for the entire conduct of elections will be that of the Election Commission. The Secretariat will extend all necessary help to the Commission. The composition of the Election Commission will be as under:-
  - (a) Presiding Officer and members of the Election Commission.
  - (b) Staff for supervision of stamping of Ballot Papers and submitting of Ballots as required to be detailed by the EC.
- 3. In case the Election Commission so desires, a meeting shall be arranged with the candidates.
- 4. The Election commission is to be informed about the date, time and venue for **opening** of the **Nomination Forms** received from the contestants. The Nomination Forms will be opened and examined for correctness/ fulfilling the required QR, and accepted/rejected. The same will be signed by the Election commission(Presiding Officer/Member) and handed over to the Secretary General for preparing the check sheet. A list of accepted contestants is to be displayed on the Notice Board in EFI within **24 hours** of opening of the Nomination forms.

#### **ELIGIBILITY TO CONTEST**

- 5. All Individual /Life Members who are Indian citizens/ **NRI's** who are **18 years** of age and above are **eligible to contest**.
- 6. To contest elections for the Selection Committee members who have won medals in any of the disciplines in National Equestrian championships are eligible. A Selection Committee member may seek re election for another term by simple majority.
- 7. Members who wish to contest will be proposed and seconded by members of the EFI.

#### NOTIFICATION OF ELECTION

8. The notification of elections will be sent at the last known postal address of the members as per records held by the Federation. The Federation will not be responsible for non-receipt of this notification by any member. The notification will also be posted on the Notice Board in the Federation office.

#### **SUBMISSION OF NOMINATION FORMS**

- 9. Members desirous of contesting the election are required to submit nominations on the prescribed form, as attached with the AGM Notice. It can be collected from the office of the EFI. The same shall be filled and forwarded as under:-
  - (a) The form will be forwarded in a sealed envelope super scribed in block letters, 'NOMINATION FORM' indicating name and membership number.
  - (b) Nomination forms should reach, either by hand or registered post by not later than the **nominated date**. In case of delivery by hand, members it will be responsibility of the members to obtain a receipt. Forms received after the due date and time will not be considered.
  - (c) Each candidate, will deposit Rs 1000/- as a deposit along with the Nomination form.
  - (d) The names of contestants will be filled in the Nomination form as they want it to appear on the Ballot Paper.
  - (e) All govt officials (who has not been athlete at national level) filling nomination forms for elective post of Executive Committee members are required:-
    - (i) to submit a certificate stating that they have not been elected earlier as executive committee member of efi failing which their nominations will be cancelled.
    - (ii) submit a noc from their respective departments.

#### **WITHDRAWAL OF NOMINATION**

10. Last date and time for withdrawal of nomination will be 07 days prior to the election failing which nomination fees will not be refunded.

#### **REJECTION OF NOMINATION PAPERS**

- 11. Nomination papers will be opened by the Election Commission on (nominated date). The Nomination forms duly signed by the Election Commission will be handed over to the EFI Secretariat for preparing check sheet.
- 12. The nomination forms are liable to be rejected for any of the following reasons : -
  - (a) Late receipt of nomination papers.
  - (b) Incorrect membership number.
  - (c) If the candidate, his proposer or seconder is under suspension or has not cleared his dues upto and including the last date and time of filing the nomination form.
  - (d) Form is not in consonance with guidelines in the statutes

#### **VOTING RIGHTS**

13. All categories of members namely Life members, Individual, State Associations Institutions/Clubs/Units are eligible to vote. Members under suspension are **NOT** eligible to vote.

#### **ELIGIBILITY TO VOTE**

- 14. The following categories of members are NOT eligible to vote :-
  - (i) A member who has failed to pay the annual dues, by 31 Mar of the year will be automatically disqualified from voting rights in ensuing General Assembly/ Extra Ordinary General Body Meeting.
  - (ii) Members under suspension are NOT eligible to vote.
  - (iii) Honorary President, Honorary Vice President and other Honorary Members and Ex-officio Members do not have voting rights.
  - (iii) State associations with provisional membership do not have voting rights.
  - (iv) Any other category mentioned in the Statutes.

#### **VOTES/ PROXY VOTES**

- 15 (a) All Individual/Life members will have one vote. He/She can hold Proxy of maximum of one other Individuals/Life member.
  - (b) Each State Association, Institution, Club or Unit has two votes and will be represented by a delegate (endorsed by an office-bearer). A State Association /Individual/Club/Unit may sent proxy through the delegate of another State Association/Individual/Club/Unit. No unit delegate can hold more than one proxy of two votes in addition to their own.

#### **BALLOT PAPERS**

- 16. On finalization of the list of contestants, the draft for printing of Ballot Papers is to be approved by Vice President (Administration). The names will be printed in order of membership number seniority. The ballots are assigned a color code for various posts.
- 17. The Ballot Papers, on receipt, are to be checked for correctness. Each Ballot Paper is to be stamped with the EFI round rubberstamp and initialed by the President/Member of the Election Commission.

#### **CANVASSING**

18. No canvassing is permitted on the day of elections within the complete area of the venue of elections. The candidate or their supporters are prohibited from canvassing in any manner and issuing any posters, pamphlets, hand bills or any other election material in support of their candidature within the premises of the venue of elections. This will be supervised by the Election Commission on the day of the polling. Violation of this will result in disqualification of the candidate.

#### PRESENCE OF CONTESTANTS OR THEIR REPRESENTATIVES

- 19. The members contesting the election or their authorized representative, (only EFI member) duly authenticated and permitted by Election Commission in writing, can be present at the following stages only: -
  - (a) Prior to voting to verify that ballot boxes are intact.
  - (b) After voting when ballot boxes are opened.
  - (c) During counting of votes.

#### **CASTING OF VOTES AND COUNTING**

- 20. The Election Commission staff before issuing the ballot paper to the member will ensure that the member is in possession of his membership card, is not a defaulter and is not under suspension. The Ballot Papers will be collected by the members auth delegate endorsed by an office bearer after duly signing on the membership roll. Votes will be cast under the supervision of the Election Commission.
- 21. Marking of Ballot Papers by voters will be by the markers positioned in the voting booth.
- 22. Ballot boxes with necessary material will be placed at the election venue. These boxes will be sealed and after votes are cast time for casting of the votes will come to an end immediately after three hours of start time as declared by the election commission boxes will be opened by the Election Commission in the presence of contestants or their authorized representative, duly authenticated and permitted by Election Commission, to avoid any representation at a later date.
- 23. On completion of casting of votes, all the contestants or their representatives to be nominated in writing will be called inside the venue and will be allowed to witness the entire process of counting of the votes and compilation of results. Complaints, if any, with regard to the elections will be raised by the contestant on the spot in writing to the Presiding Officer of the Election Commission for appropriate action after deposition of fee Rs 1000/- (non refundable if the complaint is not upheld). After the results are finalized, no representation with regard to Election process and results will be entertained. The decision of the Presiding Officer of the Election Commission will be binding on the contestants.
- 24. In case of equality of votes, the Election Officer shall determine by lot which candidate shall be declared to have been elected.
- 25. The decision of the Election Commission is **final**.

#### **DECLARATION OF RESULTS**

- 26. The results of the election, compiled and signed by the Election Commission are to be handed over to the President/Secretary General, EFI, by the Presiding Officer, Election Commission, for announcement during the General Body Meeting / Extra Ordinary General Body Meeting. A final list of the elected members to the Executive Committee is to be displayed on the EFI Notice Board on the next working day by 1300 hrs.
- 27. Thereafter, the used Ballot Papers alongwith the result sheet duly signed and sealed by the Election Commission shall be handed over to the Secretary General by the Presiding Officer and shall be kept under the safe custody of the Secretary General till the next election.

#### Appendix 'T'

## SELECTION CRITERIA 18<sup>TH</sup> ASIAN GAMES: 18 AUG TO 02 SEP 2018

- 1. Proposed technical standards for various disciplines of equestrian have been officially communicated to EFI by the org committee 18<sup>th</sup> Asian Games. Based on technical standards for Dressage, Jumping and Eventing, the following selection procedures have been formulated and shall be implemented as under:-
- Events.

(a) Dressage Team - Prix St-George (Test)

Dressage Indl - Intermediate - I (Test) and

Intermediate (I) Free Style to Music

(b) Jumping Team - Height - 1.45m Jumping Indl - Height - 1.50m

(c) Eventing Team & Indl - CCI 1\*

- 3. Selection qualifiers/trials for the 18<sup>th</sup> Asian Games for Dressage, Jumping & Eventing will be conducted by the Equestrian Federation of India between 01 Aug 2017 to 31 May 2018 and the technical standards for qualification are att as Appx.
- 4. In case of change in criteria of the Asian Games this criteria will be revised accordingly.
- 5. Dope Testing will be conducted in all the trials and during the Coaching Camps before the definite entries are sent to the Asian Games OC.

#### **Eligibility**

6. Riders: A rider must be citizen of India with a valid passport.

7. Age of rider: 16 yr old (on the day of commencement of last trial).

8. Horse: **Eventing**: 06 Yrs and above are eligible (born in 2012 or before)

Dressage : 07 Yrs " (born in 2011 or before)
Jumping : 08 Yrs " (born in 2010 or before)

9. Quarantine: In accordance with the quarantine/health protocols formulated by the Org Committee in consultation with FEI.

#### Restriction on horses

10. There shall be no grade restriction on horses. However, for CCI 1\* only qualified horses will be eligible as per MER Criteria of FEI. Horses nominated for a particular discipline e.g Dressage/ Jumping/Eventing shall only be allowed to participate in a discipline for which the horses are nominated. Under no circumstances a rider/horse combination shall be allowed to participate/compete in other disciplines. However rider can participate on a different horse in a different discipline

#### Technical standards for selection qualifiers/trials for Dressage (Indl & team)

- 11. The test for selection of Dressage Team & Indl will be Prix St-George (Test) and Intermediate I (Test) and intermediate (1) free style to music respectively. For a team or Indl entry, a rider will have to score mini 67% & 70% respectively in each selection qualifier/trial. A total of 05 trials will be conducted, 03 best performances as a horse rider combination will be considered for selection of team. At least 03 member jury will judge all the selection qualifiers/ trials and the composition of jury will be as under. Any trials less than the above qualifying percentage will not be considered.
  - (a) Prix St-George (Test) FEI Judge 03 members
  - (b) Intermediate Intermediate-I (Test) and intermediate (1) free style to music

FEI Judge - 03

#### Jumping Indl/ Team (CSI 2\* Standard)

12. The height for all the team/Indl selection trials will be 1.40m/ 1.50m. Minimum 66% of the jumping course will be of full height and spread. A total of 05 qualifiers/ trials will be conducted, 03 best performances (as a horse rider combination) will be considered towards calculation of team/ indl merit. The indl will only be considered for selection if his/her score does not exceed 04 penalties in each trial (including time penalties) in total 03 trials. In case, the team of 3 / 4 riders are not selected for Asian Games and if any rider wants to qualify for Asian Games for individual category then he/she has to participate in minimum three trials of 2 rounds competition at the height 1.5 mtr and score of best 2 trials will be taken into account. The competitor should not incur more than 04 penalties in one trial.

#### **Eventing (Indl & Team)**

- 13. A total of 05 trials will be conducted of which scores of best three results will count towards selection. The technical standard of selection trials will be of CCI 1\* level.
- 14. To equate all the riders participating in trials in India and abroad the least aggregate of the penalties of the three selection trials in order of merit will count towards the selection of team / indl members. Any score more than 53 penalties (including time penalties) will not be counted towards selection. For indl selection a score less than 45 total penalties will be considered.
- 15. All the selection trials will be held under the following officials:-

(a) Jury - 03 FEI Judges

(b) Technical Delegate - FEI TD

(c) Chief Steward - FEI Listed

#### **RIDERS BASED ABROAD**

16. Official score sheet/results of the FEI competition duly endorsed by the President ground jury and TD will be communicated. <u>Telephonic intimation with in 24h by the rider is mandatory</u> on completion of the competition for compilation of results. The specifications of the show jumping course duly endorsed by President ground jury and TD will also be forwarded along with the official results.

#### Selection of riders/horses based abroad

- 17. On basis of the foregoing experiences, following is the criteria for considering selection of riders/horses based abroad:-
  - (a) Technical standards and specification for all trials in all disciplines for riders/horses abroad will be same as standards for riders/ horses in India. For Dressage only CDI / National Championship/ Eventing CCI / National Championship and for Jumping only CSI\*\* / National Championship will be considered.
  - (b) Cut off date for selection of riders /horses abroad will be same as for riders/horses in India (31 May 2018).
  - (c) Performance of the rider and horse desired to be entered will be considered as a combination in FEI official competitions/ National Championships.
  - (d) The riders will be required to strictly comply with all quarantine/vet health protocols, requisite vaccinations and lab testing for specified diseases in OIE approved laboratories as per guidelines laid down by the org committee of host country. The rider will be required to have all knowledge of the veterinary and quarantine rules/health protocols for the Games as applicable to his/her horse's location. Whilst the federation will facilitate all administrative requirements of riders based abroad with the Ministry of Youth and Sports affairs in India. However it will be the rider's responsibility to keep abreast of all the requirements and inform the Federation in advance of the same. Federation will not be responsible for not forwarding the entry of the rider by the date specified if there is a failure on part of the rider to submit any information asked for by EFI by the due date.
  - (e) If the horse selected is unsound for any reason, it will not entitle the rider to be considered as an entry on different horse (as a horse rider combination) unless qualifying result are communicated on the second horse as well within the stipulated time.
  - (f) The riders desirous of taking selection trials abroad will have to intimate the EFI about the type of competition and venue minimum 15 day in advance of the date of first vet check of the event. The trial will not be considered for selection if the rider fails to do so.

- 18. <u>MECHANISM PERFORMANCE/ MONITORING FOR RIDERS BASED ABROAD:</u> Performance of selected/reserve Rider based abroad will be critically monitored as horse rider combination by a member of Selection Committee. Member Selection Committee will visit venue and monitor the performance level of rider, fitness of horse and Veterinary Protocol, if required. They will render report to Selection Committee and National Federation.
- 19. The under mentioned reasons/points given by the riders based abroad or desiring to be selected on horses leased/being imported from abroad are <u>unacceptable</u> to the National Federation towards the selection for the 18<sup>th</sup> Asian Games for team/individual competitions of all disciplines.
  - (a) Rider requesting for additional/exclusive trial.
  - (b) Results of riders will also be matched from the results on FEI Website for the FEI Competitions.
  - (c) Identification of the horse and rider combination desired to be selected is not made clear till the last stage or the horse finally intended for the competition is different than the horse whose results have been intimated to the federation earlier for selection.
  - (d) Consent letter from the owner/lease stating that the horse will be made available to the rider and National Federation to be fielded as an Indian entry in Asian Games is not sent by 31 May 2018.
  - (e) Location of the horse and expenses in freight/ to and from location of horse to venue of the Asian Games competition are to be furnished by 31 May 2018 for seeking budgetary support for the Indian team from Ministry.
  - (f) A FEI VET's certificate to effect that the horse is sound, free from infections/contagious diseases and not having any prohibited substance (dope tested) at the time being considered towards selection is not forwarded by 31 May 2018. It will be the responsibility of the rider to ensure that the horse has been given the mandatory vaccinations based on vet protocols required by the host country as per laid down schedules and guidelines in vogue.
- 20. Indian riders based abroad and selected to represent India will only be allowed to have one person as coach/groom/vet/horse owner to accompany them to the games on Government cost.

#### General procedures to be followed for riders based in India/abroad

- 21. The rider will certify before commencement of qualifiers/trials/competitions that he/she will abide by the selection criteria laid down by the federation. A written consent (as Appendix 'A') (as per Appendix 'B') in this regard shall be communicated to the federation before commencement of first trial/qualifier. In case of minors, the parents/guardians consent shall be communicated to the federation by 01 Jan 2017.
- 22. No additional/special competition or trial will be held after the designed trials/ competitions for qualification. At least Two out of five Selection Committee members will witness all the trials.

- 23. Selection will be based on aggregate of penalties incurred in the completion of all trials in India/abroad towards calculation of merit if the qualifying results as laid down by Selection Committee are met by the horse rider combination in each discipline.
- 24. Riders riding 02 or 03 horses with cumulative penalties incurred on each horse will not be clubbed for the benefit of the rider for calculation of merit. Points/ penalties earned by the rider will be maintained on each horse (horse-rider combination) till final trial and merit will be worked out at the end of the trials by the selection committee on 31May 2018.
- 25. At the end of qualifiers/trials/competitions in India/abroad, Selection Committee will select riders & their horses for each discipline by 01 Jun 2018. All selected and reserve riders will attend the coaching camp under the Indian and foreign coaches (except riders based abroad). The final selection of the team will be done keeping in view their merit in the selection trials, fitness of the horses/riders during the coaching camps (as a horse rider combination). A separate assessment for fitness of horse/rider will be held before the final entries for the Asian Games are sent. The selection for the team, individual and reserve riders for each discipline will be as under:-
  - (a) Dressage 6 riders (probables).
  - (b) Jumping 6 riders (probables).
  - (c) Eventing 6 riders (probables).
- 26. Selection committee will select the following officials for each discipline based on competence, knowledge and experience after official declaration of PROBABLES:-
  - (a) Indian coaches for each discipline.
  - (b) Manager
  - (c) Vet Doctor
  - (d) Assistant Vet Doctor
  - (e) Quarantine Protocol Officer
  - (f) Farrier
- 27. The Selection Committee in their minutes will give details of all the individuals who have applied for the post of Indian Coaches for each discipline, Doctors, managers farriers etc. with their credentials and modalities of selection to the Executive Committee, IOA, SAI & MYAS.
- 28. Selection Committee will also select the Indian Equestrian Team Manager based on competence, experience, exposure and knowledge of rules and regulation of the sport. He should not be a senior officer and should be in a position to meet the administration/ managerial requirements of the Team so that the riders and the Coaches are free to concentrate in training/competition. The manager will be associated with the Team for a minimum period of 06 months prior to scheduled departure.
- 29. The entire Selection Committee will convene for Selection of the team by 31 May 2018. This date for selection of the Indian team will apply for all riders and horses, based in India or abroad.
- 30. After the Indian Team has been selected for the Asian Games, the National Federation is empowered to explore the possibilities of leasing better quality horses from abroad for improving the chances of Medal for the selected team, if required.

- 31. At least one or two Selection Committee members will watch all the selection trials and hold discussion with coaches, jury members, organizers, vet doctors and competitors. This will facilitate better selection process and understanding about riders and horses.
- 32. Post selection of probables, the order of merit shall be sacrosanct unless there is steep drop in performance during coaching camps or the horse/rider become unfit due to some unforeseen circumstance. However under no circumstances will the coach give one horse to another rider without the consent of the selection committee who will also take the views of the original rider, other team members, foreign and Indian coach before taking the final decision.
- 33. All selected probables for all the disciplines will be considered as probables till Selection Committee in consultation with Indian and foreign coaches for each discipline again reviews the entire selection process before submission of definite entry. Fitness of riders and horses, horse-rider combination, performance during camps and original merit will be of paramount importance and will be taken into consideration for final selection of individuals/teams. The entire selection process will be reviewed by the selection committee in consultation with coaches, vet doctor and executive committee before definite/confirmed entries are forwarded to organizing committee of the Asian Games in order to ensure best teams/individuals are selected to win medals for the country. In case of a change in original merit of team/indl entries, the selection committee will be bound to endorse complete justification on selection/weeding out of a horse-rider combination.
- 34. <u>Note: EFI reserves the rights to amend its selection criteria as necessary, particularly where there is a change to the qualification system or circumstances affecting the nomination/entries process.</u>
